We offer video streaming with licensing terms of one year and perpetual use.

- 1) Streams are served to institutional users via password-protected access to a Vimeo stream. Professors may share the film with students by including links and passwords on their class sites. Users may access the stream from any location on or off campus.
- 2) Alternatively, institutions may request a file to upload to their own in-house streaming system.

Professors may share the film with students by including links and passwords on their class sites. Users may access the stream from any location on or off campus.

The files used for the Perennial Films streaming platform are H.264 MPEG-4 files that are processed to enable adaptive streaming. The files should not have any issues playing back on any devices. Additionally, Firefox, Safari and Internet Explorer will access and playback the film.

### **Definitions**

**1. Term – Limited License.** The term of this License Agreement with respect to Streamed Content shall be concurrent with the length of the license chosen or other agreed-upon terms. Upon expiration, non-renewal, or any termination of the license, all Licensee's rights to use the Content shall cease. License period commences at the time the license is purchased.

**2. Educational Use:** Exhibition or display of Streamed Content or DVD Content in educational markets including, but not limited to, primary schools, middle schools, high schools, colleges, universities, libraries, museums, hospitals, companies, and nonprofit organizations and individual exhibition or display of Streamed Content or DVD Content by Authorized Users studying, researching or working through primary schools, middle schools, high schools, colleges, universities, and distance learning programs.

**3. License:** The electronic permission granted to you under these Terms of Use for the purpose of streaming, displaying or exhibiting the Streamed Content or DVD Content to Authorized Users.

**4. Streamed Content:** All materials purchased and/or licensed from Perennial Films for streaming purposes including, but not limited to, video, audio, graphics, text, images, and interactive media.

### **Grant of Rights**

1. Perennial Films makes its content available to educational institutions by means of physical media (DVDs) and via direct digital streaming. In addition to the terms and conditions set forth herein, the following license terms shall apply to each of the following respective media.

2. Subject to the restrictions set forth herein, Perennial Films grants licensee a limited, non-exclusive license for the Term to stream, display and exhibit the streamed content for classroom use and in other related venues for the educational use of authorized users. Any other use of the streamed content must be licensed through special arrangement with Perennial Films. The Term Fee shall entitle licensee and its authorized users to receive unlimited online access to the streamed content.

## **Restrictions**

1. Content licensed for educational use may only be shared by authorized users within a single, geographically unified campus. Permission is also granted for authorized users of distance learning from that campus and authorized users at a satellite campus of that campus, provided that they bear the same institutional name and affiliation.

2. Files may be used for in-class instruction, inclusion in course management software, library research, extracurricular activities, distance learning programs, public performances (provided admission is not charged) and any other activity directly administered by the licensing campus.

3. Licensees may not telecast, cablecast or deliver from any website open to the public any content licensed under this agreement nor may they lend, rent or donate any of the licensed content to another organization or campus for use in activities.

4. Licensee may not charge a fee or receive any form of compensation for any public screening of the streaming file.

5. Sharing of streamed content with other institutions, or with users not specifically affiliated with the unified campus is not permitted.

6. Licensee may not make or distribute copies of the streamed content, or electronically transfer the streamed content from one computer to another or over any other Internet Server or other communications network, except as permitted by these terms of use. You may not modify, transfer, or create derivative works based on the streamed content or any part thereof.

7. Licensee may not infringe on or violate the intellectual property, privacy, publicity, or other rights of third parties whose work is embodied in the streamed content, including the rights of any third parties in any sound recordings, musical compositions, photographs, artwork, literary creations, or other copyrightable works of any kind or nature.

All other rights not expressly granted are reserved by Perennial Films. Streamed Content may not be rented, loaned, sub-leased, re-sold or sub-licensed to others. Streamed Content may not be digitized, transferred, altered, duplicated or reproduced by any means except as expressly provided in this license without prior written authorization of New Day Films.

This streaming license is expressly conditioned upon receipt of payment by Perennial Films of all applicable fees and taxes.
